Flint Hills Area Transportation Agency (Owner) soliciting firm fixed bid proposal from qualified Vendors to acquire Fixed Route CAD/AVL, Paratransit/Microtransit CAD/AVL, Planning and Scheduling Software for FHATA operations. Bids for the Fixed Route CAD/AVL, Paratransit/Microtransit CAD/AVL, Planning and Scheduling Software will be received at FHATA Facility located at 5815 Marlatt Avenue, until the 13th of February 2026 at 2:00 PM, central standard time (CST). Bids must be submitted in a sealed envelope clearly marked: *Bid #FY25- 1003-SOFTWARE*.

Public bid opening will be hosted in person and via TEAMS (Online) on the 13th of February 2026 at 2:00 PM (CST). The location and call information are provided in the bid documentation (Section A Bid Schedule).

This project will be funded in part by the United States Department of Transportation (DOT) and managed by the Federal Transit Administration (FTA), or Kansas Department of Transportation, or a combination thereof. The contract will be between the selected firms and FHATA and will contain required federal and state procurement terms and conditions, which will be applicable irrespective of funding source. The highest procurement standards, terms and conditions will apply.

In connection with carrying out this project, the Bidder shall not discriminate against any employee or applicant for employment because of race, religion, color, sex, age, national origin or handicap. The FHATA reserves the right to solicit or to waive a new solicitation, for new bids if sufficient effort, as determined by FHATA, has not been made to comply with the DBE goals and requirements. The Owner reserves the right to accept or to reject any and/or all bids, to re-advertise for bids and to waive any informality in any proposal and to determine the most responsive bid by its own criteria, as described within the specifications.

No person or entity submitting a proposal in response to this RFQ, nor any officer, employee, agent, representative, relative or consultant representing such a person (or entity) may contact through any means, or engage in any discussion concerning the evaluation and award of this contract with any member of the FHATA's Board of Directors or any employee of FHATA during the period beginning on the date of proposal issue and ending on the date of the selection of the Contractor. Any such contact would be grounds for disqualification of the proposer. Contact with FHATA Procurement Department staff during such time period must be limited to technical questions, and discussions leading to Best and Final Offers (BAFOs).
